"I am looking forward to continuing tech11's successful growth strategy together with the strong team and unlocking new market potential," von Ameln says.

With Fabian Halbmann as Chief Technology Officer, Markus Rheindt as Chief Operating Officer, and Matthias Muhler as Chief Product Officer, the leadership team was strategically expanded. This strengthened setup provides a solid foundation for further expansion and the continued development of the state-of-the-art tech11 Insurance Platform.
